## **Awards Galore**



### **SCAM SERIES**

### **2G Spectrum**

The 2G spectrum is one of the biggest scams reported in India and is listed as the world's biggest abuse of executive authority by The Time magazine. According to the CAG (the Comptroller and Auditor General of India) report, In 2008, Mr. A Raja, a former Indian telecom minister, issued 122,2G licenses to telecom operators on a first come, first served basis at 2001 prices by which the country suffered a loss of Rs.1.76 lakh crore. Moreover, license holders sold significant stakes to Indian/foreign firms at a higher premium.



Therefore Mr. A Raja is accused of manipulating auction rules to benefit selected telecom players and has been charged with criminal breach of trust by a public servant, criminal conspiracy, cheating, and forgery, as well as accepting illegal gratification under the Prevention of Corruption Act. On February 2, 2011, he was arrested by the CBI and was granted bail on May 9, 2012. On January 14, 2021, the CBI filed a new appeal in the Delhi High Court against former Telecom Minister A. Raja's and others' acquittals in the 2G spectrum allotment scam case.

# ADITI GUPTA MENSTRUPEDIA

Aditi Gupta runs Menstrupedia, the world's most innovative company with regard to educating people about periods. It is an initiative that she is a co-founder of, and that uses comic books and relatable media to de-stigmatize menstruation. Aditi Gupta is an alumnus of the National Institute of Design, Ahmedabad, and has been a menstrual educator for the past 8 years now.

She aspires to create a future where menstruation is not shameful but a welcoming change. Menstrupedia is a complete guide to educate people around the world about the feminine cycle.

Aditi has been invited to share the model of her work in the field of menstrual health and awareness in seven countries. She also spoke on the Breaking Taboo Panel at the Thomson Reuters Foundation Trust Women Conference London. Over 10,000 schools in India use these comic books as a part of their curriculum and the comic is available in 20 languages and is used in 23 countries around the world.

Aditi was named in the Forbes India 30 under 30, 2014 and was also listed in BBC 100 women.
