Preamble

1. Objectives

- 1. To create an inclusive environment by avoiding discrimination, exploitation and exclusion of differently abled students and employees from all spheres of work and education.
- 2. To create suitable regulatory mechanism for effective delivery of services to differently abled students and staff of the college.
- 3. To ensure full participation of persons with differently abled and to provide them the equal opportunities for development.

4. Infrastructure supports and convenience:

- College will update campus infrastructure to make it more accessible for people with Differently abled. College will construct ramps, rails, walker, wheel chair for differently abled students and employees.
- College will allocate classes, exams at ground floor, if no ramp are available to 1st floor persons with Differently abled.
- College will take initiatives for upgradations of mechanical and technological support for people with Differently abled including differently abled friendly mechanisms.

5. Academic Support:

- The College library will provide support for differently abled category.
- College will take initiative for collecting and developing academic resources required for persons with differently abled.
- For students of dumb and deaf category, college will consider special assignment for Internal Assessment instead of Seminar, Group Discussion and Viva.
- The authority, faculty members and staff will provide help to the differently abled students.
- Parking Provisions will be reserved for differently abled students with sign boards.
- Scribe facility will be provided to visually impaired students.
- Extra time in the examination will be given to the differently abled students.
- Concession will be given in passing mark.
- Faculty will provide personalized instructions by adapting teaching methods using alternative assessments and modifying assignments to meet the student's unique needs.

6. Sensitisation and Awareness:

- College will regularly organise awareness and sensitisation programmes and events for staff and students to make the college a safe space for people with differently abled.
- College will encourage students from the PWD category to aspire for higher education. Teachers will provide PWD sensitisation in its mentoring practice.
