#### 4.0 Plans, Process and Procedures:

- ➤ Establish committee or task force comprising of deans, Principal as chair person will hold meetings to discuss the objectives of the code of conduct ensuring it aligns with the college mission and values.

- Consider the needs of diverse student populations and ensure the code is inclusive and culturally sensitive.
- > Implementation and communication:
- ❖ Develop a comprehensive communication plan to introduce the code of conduct to all students, faculty and staff.
- Propagate/Distribute the code of conduct widely using various channels like college website, student handbook, orientation sessions.
- **Establish reporting mechanism and procedures for alleged violations.**
- Provide support resources for students who have questions or need assistance regarding the code of conduct.

# 5.0 Rules, regulations, Code of Conduct:

- ❖ The college lays stress on attendance. It is compulsory for the students to have a minimum of 75% in each course to be eligible for the end semester examination.
- ❖ Students should be punctual and attend all their lectures regularly.
- ❖ Students are required to maintain discipline which is essential for the development of the individual and the college as a whole.
- ❖ All the students are expected to conduct themselves in a manner befitting the college community and due respect should be given to all the faculty members.
- ❖ Students are required to come decently dressed to the college. Dignity and decorum should be maintained at all times.
- ❖ Students should not bring valuables to the college. It is their responsibility to take care of their belongings. The college will not be responsible for any loss of valuables.
- ❖ Every kind of demonstration that restricts freedom of the members of the college or disrupts any activity in the college is banned.
