



IQAC Highlights 2024-25

- An **IQAC External Audit** was conducted on 29th June 2024 to evaluate the effectiveness of internal quality assurance mechanisms.
- An External **IQAC Meeting** was conducted on 2nd July 2024 to review quality initiatives and action plans.
- An **Induction Program for first-year undergraduate students** was organized from 3rd July 2024 to 4th July 2024 to orient students to institutional policies and academic culture.
- A five-day hands-on training program on **Social Media Profile Building** was conducted on 13th July 2024.
- A **Faculty Orientation** Program on *NAAC Assessment – 4th Cycle* was organized on 18th July 2024 to familiarize faculty with accreditation processes.
- **NAAC Peer Team** visit was held on 4th and 5th August 2024, and college was reaccredited with A Grade with CGPA 3.24.
- A **Faculty Orientation Program** for newly appointed faculty members was conducted on 16th October 2024.
- The **Swachhata Hi Seva Hai** – *Swachh Bharat Campaign* was organized on 8th February 2025 in collaboration with the Department of Zoology for auxiliary staff to promote cleanliness and hygiene.
- **Shreyasi Awards** was organized in collaboration with the Centre for Women Studies (CWS) on 13th March 2025 to recognize and encourage women excellence.
